By using our services, your order will be processed at the Secretary of State's office with a quicker turnaround time than if you were to mail your request directly to their office. Documents mailed to the State's office can generally take 4-5 months to be processed. Currently, service companies are not allowed to have their employees physically wait at the counter while orders are processed. Therefore, we drop off and pick up documents on each state allotted business day.

When your order is completed we will pick it up from the Secretary of State's office, scan and e-mail you copies of the documents and send the original documents back to you. We can either put the documents in first class mail or use a pre-designated mailing service.

Below you will find our "trade" service pricing only available to Attorneys, CPA's and other professionals who routinely need documents couriered to the California Secretary of State.
